VI. New Items:

Kauai Conservation Conference - Jackie

Plans are progressing for the Conference and the steering committee has received word that the venue will be the Radisson thanks to Jay Furfaro (Kauai County Council), who has made it possible to have this site free of charge. This will be a wonderful opportunity for all aspects of conservation to come together to network and "teach the teachers". There will be many topics of interest for a wide variety of subjects. Prevention/Early Detection Program – Kristin

To follow up on the last meeting to address the need for early detection and rapid response, Kristin has contacted other ISCs and is working on putting together a Prevention Species List. This list will then be incorporated into an education component at our monthly staff meeting with the KISC crew. Species identification will be reviewed as well as habitat, reproduction, and life cycles. The crew will then conduct surveys in likely areas of introduction as well as keep an eye out in their daily target work. Surveys will focus on ports of entry and nurseries.

Super Ferry – Keren

Keren was asked by Joanne Yukimura (Kauai County Council) to be on the Super Ferry Advisory Board. This board is comprised of members from various sectors of the community and will provide feedback regarding concerns. This feedback will be related to both the State Department of Transportation and the Super Ferry. KISC, at this time, does not have a working relationship with DOT, and this will be a great opportunity to establish one. The Advisory Board will meet quarterly.
